The 15th meeting of the Conference of the Parties (COP 15) to the UN Convention on Biological Diversity (CBD) in Kunming, China will define the new post 2020 agenda for biodiversity and set the course for the next decade. The theme of the landmark 2020 UN Conference is "Ecological Civilization: Building a Shared Future for All Life on Earth".
